- A) The responsibility of maintenance and defect liability period will have to be done by the successful bidder for 2 (Two) year.

The Chairman, Uttarpara-Kotrung Municipality, shall issue work order & the Chairman, Uttarpara-Kotrung Municipality, will make the payment.

- D) If the agency fails to do the work as per the agreement with the Department, penal action in the form of forfeiture of earnest money and or security deposit money, as decided by the authority, will be imposed on the agency and the decision of the authority will be conclusive and binding. - 13) Prospective applicants are advised to note carefully the **minimum qualification criteria** as mentioned in **'Instructions to Bidders'** stated in Section 'A' before tendering the bids
- 14) Conditional / Incomplete Quotation will not be accepted under any circumstances.
- 15) The intending Tenderers are required to quote the rate online.

## 21) Qualification criteria:

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.Q. & Quotation Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Quotation Documents.

# iv. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.

## v. Submission of quotation:

Quotation are to be submitted through online to the website stated in Clause A.1. in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

If any contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished. **No MSME is allowed for the E.M.D. exemption.**
